All corporate photographic services are on offer:

- Receiving awards, fundraising events

ALL CORPORATE BOOKINGS INCLUDE:

- All bookings include restricted access to an online collection of the images for 8 weeks after upload – You will be notified by email one week prior to the deletion of your collection.
- It is highly recommended that you **download and backup** your images during this time, please get in touch if you require any help with this and [Backup your proofs for future reference!!](#)

ADDITIONAL CHARGES:

- Extra Touch-up work per image -£10
(skin smoothing, teeth whitening etc - basic editing & processing is included)
- Additional upload after collection is deleted -£30
(8 weeks access included)
- Extend online access for 8 weeks -£20
- Annual online access subscription -£45
- Backup USB Flash Drive -£20
- **Travel time per hour** - £75
(First half hour of travel each way Included in shoot fee.)
- **London-based Travel Time minimum** -£150
Travel time driving may differ depending on distance/time/traffic contingencies.
- **Congestion Charge/Tolls/Train Fares/Parking Fees** added to the final invoice with a PDF Copy of the receipt
- **Overnight accommodation and meals** are to be provided or reimbursed by the client.

TERMS AND CONDITIONS:

- All Corporate bookings are subject to a £150 non-refundable deposit to secure your date to be deducted from the final bill or act as a cancellation fee if the shoot cannot be rescheduled.
- The photo shoot CAN be rescheduled without penalty with a minimum of 48 hours' notice given.
- Proofs are available within 5 working days
- Finished images are available within 5 working days of shoot date or 5 working days after choices are made.
- Parking and instructions for unloading must be provided if necessary.
- Photographer retains copyright – images are not to be sold or provided to any third parties.
- Images will be used to promote Ingrid Weel Photography in print, online and on the Ingrid Weel Photography web site. All considerations for timing etc. of publicizing the images will be honoured.
